European Social Dialoque *(ESSDC)*

The second meeting of the ESSDC (European Sectoral Social Dialogue Committee) was held on 20th May 2015 in Brussels. The main subject was 'sustainable employability'.

Social partners will produce a joint document with recommendations and wishes from the 3 subcommittees: Professional sport, Not-for-Profit Sport and Active Leisure and Outdoor Sport. Of course you can also discuss the subject with your representation on national level or you can send an email to ease@easesport.eu.

A database with all <u>current members</u> (employers and employees organisations) in Europe is available on the website. In the near future we would like to add all possible candidates for membership in European countries for social dialogue.

It is an overview of the (start of) social dialogue.

To further investigate the possible development of social dialogue in other European countries a new project will be submitted to the European Commission. The draft project was discussed in the meeting. The deadline of submission of the project is mid June.

In the meeting the Sport unit of the European Commission and UNI Europa reported on various activities and on the EU expert Groups.

COVENANT SIGNED!COÖPERATION WITH EUROPEACTIVE AND EC-OE

After intensive consultation and several meetings a covenant for

coöperation with EuropeActive and EC-OE was signed on the same day as the ESSDC meeting.

EASE and UNI Europa have a direct role in the social dialogue at European level in the sport. EuropeActive and EC-CO do not have a traditional role in the social dialogue, but they have excellent representation from employers in the fitness and outdoor sector. By coöperating we try to combine the best of both parties and to share knowledge and experiences. EuropeActive and EC-OE will be admitted to the social dialogue as observers. Both will contribute their contacts and experience in their sectors in order to strengthen the social dialogue. Online instrumente Risk Assessment

The day after the ESSDC a meeting of the steering group OiRA (Online instrument Risk Assessment)was held as part of a project of all social partners. After the summer reces an online risk assessment tool will be produced for Health & Safety. In fact, there will be three tools for Professional sport sector, Not-for-profit sector and Active leisure sector. The test phase of the tool will be coming June and July.
