ESSA Sport

European Sector Skills Alliance for Sport and Physical Activity project launch On the 21st of November, EOSE together with Uni-Europa and EASE —who are leading the project- officially launched the ESSA-Sport project together with the national partners.

ESSA-Sport is a process of research and consultation designed to create a Strategic Action Plan as a basis for on-going collaboration to improve the supply of skills to the sport and physical activity sector including fitness and the outdoors.

Strenghtening employability in the sport sector.

The European Sectoral Social Dialogue Committee for Sports has adopted a joint opinion on 'Strengthening employability in the sport and active leisure sector'.

The social partners in the sector, European Association of Sport Employers (EASE) and UNI Europa Sports, as well as the observing partners EuropeActive and the European Confederation of Outdoor Employers (EC-OE) ('the partners') want to proactively shape the future of the sector.

A crucial step is being taken with this joint opinion aiming to identify the barriers to employability in the sport sector and to offer recommendations as to how these barriers can be overcome. The statement is addressed to European and national policy makers who are encouraged to use its conclusions to support new and existing policy initiatives.
